Contracting Party: Hereby agrees that the Participant Name will participate in the activity (Activity Name) organized by (Organizing Unit) and entrusts the organizer to provide care and supervision during the event. The two parties agree to the following terms:

- Article 1 All off-campus activities, on-campus activities lasting two or more consecutive days, and any on- or off-campus activity with a fee of NT\$250 or more are subject to this contract. Parental consent forms and parent-related fields may be omitted for activities that do not require parental consent.
- **Article 2** This is a formal agreement. Parents authorize the organizer to care for the participant (including staff) during the activity. Parents must inform the organizer of any changes.
- **Article 3** The organizer must use legally licensed vendors for food, lodging, and transportation during the activity, complying with national standards and relevant laws.
- **Article 4** Parents must inform the organizer of the participant's health conditions or special needs in advance and provide any necessary medication or equipment with instructions. If there are major changes to the leader, schedule, venue, or content, the organizer must notify the parent.
- Article 5 In the event of sudden illness, serious sickness, or accident during the activity, the organizer must provide
- Article 6 A participant shall not be allowed to continue participation in the activity under the following circumstances:
 - 1. The participant fails to attend the activity without prior leave or notice to the organizer.
 - 2. If, during the activity, the participant exhibits any of the following behaviors and fails to correct them after being warned:
 - I. Endangering the physical safety or property of other participants.
 - II. Engaging in frequent inappropriate behavior that negatively affects other participants.
