I. To strengthen and implement health management and promotion at Yuntech, and to prevent the spread of infectious diseases unknowingly, the "National Yunlin University of Science and Technology Guidelines for Implementing Freshman Health Examination" (hereinafter referred to as these Guidelines) are established in accordance with Article 8 and Article 9 of the School Health Act and Article 4 of the Ministry of Education's Regulations for Implementing Student Health examination II. The Office of Student Affairs' Health Education Division is responsible for planning and implementing freshman health examination, as well as subsequent health management and promotion.

- III. The subjects of these Guidelines are:
 - (1) Freshmen, transfer students, and graduate students.
 - (2) Foreign students (including short-term exchange students).
 - (3) Returning students.

IV. The health examination referred to in these Guidelines should be conducted by hospitals, clinics, or medical institutions designated by the local medical association. V. The items of the freshman health examination shall be conducted in accordance with the following provisions:

- (1) Freshmen, transfer students, graduate students, and returning students: In accordance with the Student Health Examination Standards Table stipulated in Article 2 of the Ministry of Education's Regulations for Implementing Student Health Examination.
- (2) Foreign students:
 - 1. Those who stay in school for less than six months should follow the same examination items as freshmen and also comply with any new

items added by the Ministry of Education or the Ministry of Health and Welfare.

2. Those who stay in school for more than six months should submit a photocopy of the "Health Examination Items Table (Form B)" stipulated by the National Immigration Agency, Ministry of the Interior.

VI. All subjects of these Guidelines should undergo health examination. They can participate in on-campus health examination and submit reports, or they can submit their own health examination reports that are qualified within six months, but they must cover the items stipulated in Article 5. They should be completed within two weeks of the start of the school year. Those who fail to submit on time will be dealt with according to the Student Reward and Punishment Regulations.

VII. Yuntech should conduct a survey of basic health data for freshmen when they enter school, and keep records. The Health Education Division of Yuntech should keep these records for 7 years. Student health data should be kept confidential, but it is not limited to this if it needs to be provided for teaching, counseling, medical needs, with the consent of the student's parents, or other legal provisions.

VIII. Yuntech should take the following measures for abnormal health examination

(1) Implement health guidance, assist the examinee in referring abnormal items for re-examination and appropriate correction, and follow up.

- (2) For those suffering from infectious diseases, they should be handled in accordance with the relevant laws and regulations of the health authority.
- (3) For those suffering from special diseases, case management should be carried out, and their participation in activities or work should be properly arranged.

IX. Yuntech should record and file the results of health examination and corrections, and statistics, and notify relevant personnel to jointly maintain the health and safety of the examinee when necessary, and carry out health promotion activities based on the examination results.

X. These Guidelines are approved by the Health Committee and implemented after being approved by the President. The same applies to amendments.
